ABOUT

A Emerald Port Direct contract offers a fixed price for an agreed volume of grain delivered to Emerald's Port Melbourne Terminal at a future date, with Fast Pay payment terms.

WHO IS ELIGIBLE FOR PORT DIRECT?

To qualify for Emerald Port Direct contract benefits a grower must:

- Commit to a Delivered Buyer contract with Emerald Grain with delivery into Emerald's Port Melbourne Terminal;
- Return your completed vendor declaration for the deliveries; and
- Fulfill this contract with deliveries to Emerald's Port Melbourne Terminal only.

GRADES

Fixed grade contracts with FLEXIBILITY to amend contract at Market Spread to match quality on farm.

Emerald Grain will use best endeavours to accept grades other than the grade nominated on this contract. Where a higher grade is accepted, no premium or spread will apply and where a lower grade is accepted, the spread to apply will be as per Emerald Grain's spreads on date of receipt, with an additional \$4 per MT fee applied.

QUALITY

Canola: Uncapped oil bonifications on a 1.5% premium for every 1% or part thereof above and below 42%. Premiums and discounts applied as per Australian Oilseeds Federation standards.

No quality adjustments apply for other commodities.

DELIVERY

Deliveries are only accepted at Emerald's Port Melbourne Terminal, across a time period agreed by your local merchant. Emerald's logistics team will be in contact with you regarding raising an order for your deliveries, once you receive your order you are responsible for booking your timeslots with Emerald Port Melbourne Terminal.

PAYMENT

Payment will be processed within two business days from the delivery. Refer to Fast Pay Product Sheet for further details.

If for any reason Emerald Grain is unable to accept your grain at Port Melbourne Terminal and you delivery to a different Melbourne Zone delivery point you will not be eligible for Fast Pay on these loads.

TONNAGE

Minimum 25mt.



SIMPLE

Simply agree a on price on a fixed grade contract and deliver grain as per the contract.



PRICE SECURITY

Lock in a fixed price to avoid potential falls in the market.



Fast Pay

Payments will be processed within two business days from the delivery.
